Construction of RCC building of Billiground Branch. The Work includes:

1. Dismantling of wooden building of existing building rear portion area four feet depth.
2. Excavation of earth for the basement area
3. RCC Column foundation of the new construction of RCC building.
4. First phase
 - a)Removal of wooden structure.
 - b)Properly stacking of dismantled materials.
 - c)Depth of foundation 1.5mtr from the hard surface of basement floor.
 - d)RCC slab for basement floor.
 - e)Slab for basement floor.& RCC wall on all sides of the building.
